
Innovation in health technology – medicines, medical devices, diagnostic technologies, and increasingly, digital health – is transforming the way how healthcare systems are organized.




Life expectancy total population at birth 2017





AMCHAM HEALTHCARE VISION STATEMENT





Low public spending and high out-of-pocket expenditure is a critical issue for Latvia. The OECD Economic Survey Latvia (May 2019) and the EU Council Country Specific Recommendations for Latvia (June 2019) both advise to increase public spending on healthcare to provide accessibility and quality of healthcare services and reduce out-of-pocket payments to ensure equal opportunities, especially for vulnerable social groups. We positively note Health Ministry's direction towards increased governance at regional hospitals to ensure high-tech and high-competence requiring technologies are centralized at excellence centers; thus, leading to efficiencies, equal and standardized approach, and better patient outcomes. Strengthening of primary care while secondary and tertiary care becomes more distant could play an important role in increasing trust and engagement towards the reforms.







In addition to increasing health budget, ensuring proper salaries to the medical personnel, increasing the efficiency of hospitals and improving e-health, some of the issues that need immediate attention include:

- Limited healthcare funding and short-term budgeting issues with unsustainable risk-sharing solutions
- Lack of transparency and consistency in priority setting and decision-making
- Immature data infrastructure and connectivity, need for real world data framework
- Lack of patients/disease registers where epidemiological, disease, treatment and treatment outcomes data would be provided

AmCham Healthcare group has come up with several proposals including specific pilot projects^{*} that could help address some of the identified issues aiming to create more efficient, fair, inclusive and sustainable health care system with improved healthcare outcomes contributing to the development of the Latvian economy and society.
