




### The convergence of living standards has slowed

#### Gap in GDP per capita against OECD average





#### Contribution to potential output per capita growth







2021 or latest available year





Days per year per person, 2022 or latest available year





2022 or latest available year



Percent change in long-term real GDP per capita resulting from increasing the share of health and education expenditure by 1 percentage point (of total expenditure)



**Tax revenue** % of GDP, 2022 or latest available year





% of GDP





(higher values indicate better performance)





Note: Estimates based on a non-parametric technique predicting a frontier of countries that are best in maximising health outcomes for a given level of spending.



#### Gross fixed capital formation in the healthcare system


Average 2017-21 or latest year






### Nursing graduates per 100 000 population 2021 or the latest available year
